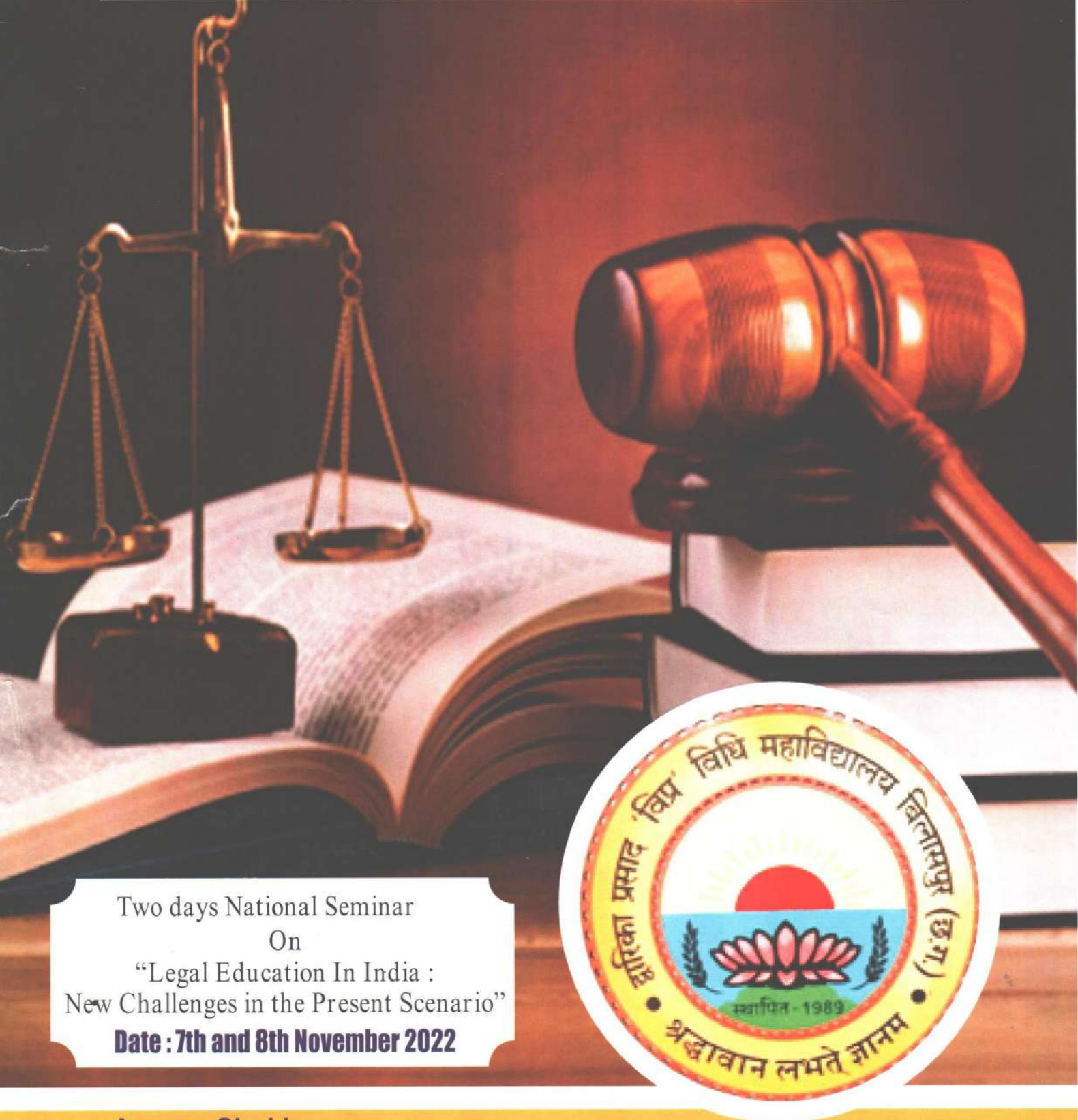

FEW WORDS ABOUT COLLEGE :

D.P. Vipra P.G. Law College, Ashok Nagar, Bilaspur was previously known as Deptt. Of Law D.P. Vipra College, Old High Court Road, Bilaspur and it was established by well-known educationist and the then Principal Late Prof. Ram Narayan Shukla and learned Advocate Late Pt. Ramakant Mishra During 1989, Shri G.P. Kaushik and Shri Subhash Kumar Mishra the two experienced Advocates of Bilaspur Bar were also associated with the institution as founder Teachers of law. During 1998-99, the aforesaid department of law achieved its new shape and image as a full-fledged independent full time law college having separate Principal and separate campus at Ashok Nagar, Bilaspur in compliance of the order of the Bar Council of India. During 2009-10 the college obtained approval and affiliation from Guru Ghasidas University, Bilaspur for introducing LL.M two years post-graduate degree programme and in 2012, the college entered in a new era of premium legal education as it achieved permission and approval from the regulatory body (Bar Council of India) to introduce five years integrated law degree (B.A.LL.B.) programme as the first institution within the territory of Bilaspur University and apart from that, B.Com LL.B. one more five years law degree programme has also been introduced by the college from this current session. During Nov. 2014 Hon'ble Judge of the Supreme Court Justice Mukhopadhyay was present on the occasion of silver jubilee programme of D.P. Vipra Law College and really it has been a life time achievement for us. Similarly the college has been actively engaged in promoting legal literacy and legal awareness among rural areas with the help and guidance of the State/District level Legal Aid Authority, and under this curriculum the college has conducted more than 30 one day legal literacy camps at various rural and remote belts of Bilaspur region.

It will not be out of place to mention here that right from the originating year of the college till the current academic session the college has been adorned and highlighted by the name of such meritorious students who have brought laurel for the institution securing position in the merit list of concerned University examinations and getting selection in Judicial Services Examination.

The present governing body under the charming headship of Hon'ble Chairman Shri Anurag Shukla and other devoted and active members is heading on the right track of academic growth with dynamic approach and certainly the college will prove its social as well as academic significance by catering to the legal educational need of the thrust area of the society.
