This is to bring to your kind knowledge that the Standing Committee of the Legal Education Committee of the Bar Council of India by virtue of its meeting held on 30th and 31st October, 2021 considered the request to grant fresh approval of affiliation to five year B.Com LL.B course and for extension of approval of affiliation to three year LL.B course and to five year BA LL.B course of D.P. Vipra Law College, Bilaspur, Chhattisgarh.

After consideration, the Committee found that the College is imparting LL.B teachings vide four sections for three year LL.B. course with intake of 80 students in each section and with two sections of five year BA LL.B course with intake of 60 students in each section.

It may be noted that though it was permissible to admit 80 students in each section before the Legal Education Rules of BCI, 2008 came into force, the maximum number of students, under the present system/Rule in existence since 2008 in each section is **60 Students**.

It is felt that the existing four sections of 3 year L.L.B. course with 80 students in each section needs to be changed to five sections by restricting the intake to 60 students in each section from the current academic year, which means the total strength of students should not exceed 300 in all for the above referred course, inclusive of all quotas.

No supernumerary quota above the sanctioned strength is allowed with the exception of 10 percent seats over and above the sanctioned seats only for Economic Weaker Section quota(EWS).

Approval has also been fit to be extended for the two sections of five year BA LL.B course.

In view of the above, extension of approval of affiliation be granted to D.P. Vipra Law College, Bilaspur, Chhattisgarh for imparting three year LL.B course with intake of five sections of **60 Students** in each section and for five year BA LL.B course with intake of two sections of **60 Students** in each section subject to payment of default amount of Rs. 14.5 lakh for admissions made by the College during the year 2017-2018 to 2020-2021 in both the courses.

After depositing the default fee, the admissions made by the College will be regularized.

As regards the fresh approval to start five year B.Com LL.B course, the same is accorded with intake of one section of 60 student for a period of one year i.e. for the academic year 2021-2022 subject to the condition that CLE maintains teacher student ratio at 1:40.

The other deficiencies pointed out by the Inspection team shall also be complied with and the compliance report be filed within two months from the date of order is received.

**Specific conditions imposed by the inspection team and approved by the Committee which are required to be complied with are as follows :-**

- 1- The college must purchase law and non-law text Books & Reference Books worth of Rs.5 Lac.
- 2- Minimum 200 Tables & Chairs must be arranged to cater the needs of class rooms.
- 3- Two law Teachers must be appointed particularly for new course. ( B.Com LL.B).
- 4- Salary of teachers must be as per U.G.C. Norms.



2. Centre of Legal Education must ensure to teach clinical subjects and give marks as per the schedule.
3. Centre of Legal Education should ensure the payment of salary to teachers as per Rules 22 schedule III, Part IV of BCI Rules.
4. The library should be furnished as per Clause 15 of Schedule III of Legal Education Rules 2008 given below :-

**Minimum Library requirement:** To start with, a Law Library shall have a set of AIR manual, Combo offer of CD of AIR Pvt. Ltd. (containing electronic version of AIR Supreme Court and High Court Data bases Research 1950-2015 (four connections each) Cr. L.J. Data Base 1950-2015(four connections) AIR Privy Council Data Base 1900-1950 (four connections) AIR Mannual latest 6<sup>th</sup> Edition(1-45 Vols.) AIR Journal 2015, Cr. L.J. 2015, L.I.C. 2015, AIR Civil Cases 2015, AIR Law Lines 2015, AIR Cheque Dishonour Reports 2015, AIR Accident Claims and compensation 2015, Institution shall get electronic versions updated every year by AIR Pvt. Ltd. Central Acts and Local Acts, Criminal law journal, SCC, Company cases, Indian Bar Review, selected Judgements on Professional Ethics and Journals with the back volumes for at least ten years and also such number of text books in each subjects taught during the period according to the minimum standard ratio of ten books for each registered students. For running integrated program, text books of such other subjects are also to be kept in the similar minimum ratio.

5. The Centre of Legal Education should keep in mind that minimum 10 sets of Indian Bar Review, selected judgments and professional Ethics published by Bar Council of India Trust and the AIR volumes/set must be promptly ordered for the library if not already ordered, as it is an essential requirement to run a law college which is stipulated by Bar Council of India, Legal Education Rules 2008 framed under a Parliament Act.
6. The Center of Legal Education is directed to make a minimum investment as provided below for upgrading it's library as per the following guideline :-

*"Today with the increasing cost of journals, books, wi-fi, e-library and online facilities including I.T. facilities, the minimum investment by each university should be Rs. 10 lakhs for each year. However for any university/deemed university in rural area, the investment should be Rs. 5 Lakh and for all other affiliated colleges in the urban area it should be Rs. 2 lakhs and in rural area it should be Rs. 1 lakh."*

7. Teacher Student ratio shall be 1:40 as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.
8. Centre of Legal Education is directed to inform the timings of the classes.
9. Centre of Legal Education must ensure that not less than three percent seats are reserved for persons with disabilities.
10. Centre of Legal Education shall equip itself to provide appropriate facilities in terms of the physical infrastructure, academic infrastructure and any other facilities required for the



effective participation of disabled students, teachers and staff in their respective activities. For e.g. (a) ramps in public buildings and (b) Braille symbols and auditory signals in elevators or lifts.

Further, the Centre of Legal Education should maintain the timing which has to be minimum 5 ½ hours with half an hour break.

**AFFIDAVIT—**

Centre of Legal Education is directed to file an affidavit to the Bar Council of India within four weeks mentioning the timing of the classes. The relevant rules of Legal Education which are mandatory to be ensured are as follows :-

Rule (xxiii), Chapter I

"(xxiii) "Regular Course of Study" means and includes a course which runs for at least five hours a day continuously with an additional half an hour recess every day and running not less than thirty hours of working schedule per week."

Rule 5 of Schedule III

"Classes may be conducted between 8 a.m. to 7 p.m. in a Centre of Legal Education, which is not fully residential. However the Library may remain open till 10 p.m."

**AFFIDAVIT-**

Further, the Centre of Legal Education should follow the attendance rule and file affidavit that they are following the aforesaid and below mentioned rule. The next inspection team shall also see whether the said rules are being followed by the university or not. The relevant Rule 12 is given below :-

*"12. End Semester Test: No student of any of the degree program shall be allowed to take the end semester test in a subject if the student concerned has not attended minimum of 70% of the classes held in the subject concerned as also the moot court room exercises, tutorials and practical training conducted in the subject taken together.*


*Provided that if a student for any exceptional reasons fail to attend 70% of the classes held in any subject, the Dean of the University or the Principal of the Centre of Legal Education, as the case may be, may allow the student to take the test if the student concerned attended at least 65% of the classes held in the subject concerned and attended 70% of classes in all the subjects taken together. The similar power shall rest with the Vice Chancellor or Director of a National Law University, or his authorized representative in the absence of the Dean of Law.*

*Provided further that a list of such students allowed to take the test with reasons recorded be forwarded to the Bar Council of India."*

Centre of Legal Education should also admit students as per the below mentioned Rule:

7. Minimum marks in qualifying examination for admission: Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants, 42% for OBC category and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 Examination in case of Integrated Five Years' course or Degree course in any discipline for

Three years' LL.B. course, for the purpose of applying for and getting admitted into a Law Degree Program of any recognized University in either of the streams.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

**Centre of Legal Education** to follow Clause-24, Schedule-II of Legal Education Rule-2008 lays down Moot Court exercises and Internship; Clause-25, Schedule-III lays down Minimum period of Internship which is quoted hereunder. **However, during the pandemic period, it has been left open to the Centre of Legal Education to choose any alternative mode with respect to the same, owing to practical feasibility of the same.**

**24. Moot court exercise and Internship:**

***This paper may have three components of 30 marks each and a viva for 10 marks.***

(a) Moot Court (30 Marks). Every student may be required to do at least three moot courts in a year with 10 marks for each. The moot court work will be on assigned problem and it will be evaluated for 5 marks for written submissions and 5 marks for oral advocacy.

(b) Observance of Trial in two cases, one Civil and one Criminal (30 marks):

Students may be required to attend two trials in the course of the last two or three years of LL.B. studies. They will maintain a record and enter the various steps observed during their attendance on different days in the court assignment. This scheme will carry 30 marks.

(c) Interviewing techniques and Pre-trial preparations and Internship diary (30 marks):


Each student will observe two interviewing sessions of clients at the Lawyer's Office/Legal Aid Office and record the proceedings in a diary, which will carry 15 marks. Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition. This will be recorded in the diary, which will carry 15 marks.

(d) The fourth component of this paper will be Viva Voce examination on all the above three aspects. This will carry 10 marks.

**25. Minimum Period of Internship:** (a) Each registered student shall have completed minimum of twelve weeks internship for Three Year Course stream and twenty weeks in case of Five Year Course stream during the entire period of legal studies under NGO, Trial and Appellate Advocates, Judiciary, Legal Regulatory authorities, Legislatures and Parliament, Other Legal Functionaries, Market Institutions, Law Firms, Companies, Local Self Government and other such bodies as the University shall stipulate, where law is practiced either in action or in dispute resolution or in management.

Provided that internship in any year cannot be for a continuous period of more than Four Weeks and all students shall at least gone through once in the entire academic period with Trial and Appellate Advocates.

(b) Each student shall keep Internship diary in such form as may be stipulated by the University concerned and the same shall be evaluated by the Guide in Internship and also a Core Faculty member of the staff each

time. The total mark shall be assessed in the Final Semester of the course in the 4<sup>th</sup> Clinical course as stipulated under the Rules in Schedule II.

**Centre of Legal Education should also follow Rule-10 of Legal Education Rules 2008 which is quoted hereunder :-**

**10. Semester system**

The course leading to either degree in law, unitary or on integrated double degree, shall be conducted in semester system in not less than 15 weeks for unitary degree course or not less than 18 weeks in double degree integrated course with not less than 30 class-hours per week including tutorials, moot court room exercise and seminars provided there shall be at least 24 lecture hours per week.

Provided further that in case of specialized and/or honours law courses there shall be not less than 36 class-hours per week including seminar, moot court and tutorial classes and 30 minimum lecture hours per week.

Provided further that Universities are free to adopt trimester system with appropriate division of courses per trimester with each of the trimester not less than 12 weeks.

**Centre of Legal Education should also follow Rule 17 and Rule 18 of Schedule III of Legal Education Rules 2008 which is quoted hereunder :-**

**Rule 17. Core Faculty:**

There shall be sufficient number of full time faculty members in each Centre of Legal Education ( i.e. ,Department, constituent or affiliated college ) to teach each subject at all point of time for running courses who can be supported by part time or visiting faculty. Such a core faculty shall in no case be less than six in the first year of the approval with both streams in operation, eight in the second year and ten in the case of third year of law courses. In addition, for the integrated course there shall be adequate faculty in the subjects offered in the liberal educational subjects as part of the course by the institution. These faculties in the liberal educational discipline in Arts, Science, Management, Commerce, Engineering, Technology or any other discipline shall possess qualification as is required under the UGC guideline or under such other standard setting body as the discipline is allotted to by any Act, statute, or Rules of the Government of India or of a State.


For the Three Year Bachelor of Law degree course only with two sections without the Honour program, there shall be minimum of 4 core faculty in the first year six in the second and eight in the third year in addition to the Principal/ Head or Dean as the case may be.

Provided that an institution intending to run any specialized or honours course must have at least three faculty in the group in which specialization and honours courses are offered.

Provided further that each full time faculty shall take as many classes in the subject or subjects as may be assigned to them on the basis of standard prescribed by 'the standard setting institution' like UGC.

Provided further, if any institution of a University, which was already affiliated to the University and approved to run professional courses of either scheme or both by the Bar Council of India after inspection of the University, falls short of required full time faculty, the new admission in courses may be required to remain suspended until new required number of faculty is procured. The University shall before starting a new academic

session, notify which institutions are only be allowed to admit fresh students.

*Provided further that if while inspecting the University it was found that in any institution of the University adequate number of full time faculty was not there in the staff, the Bar Council after giving notice to the University might give a public notice directing the University not to admit students in the new academic year in that institution.*

**Rule -18 Minimum weekly class program per subject (paper):.**

*There shall be for each paper (with 4 credit) Four class-hours for one hour duration each and one hour of tutorial/moot court/project work per week.*

Authenticated signed and certified Bank Statements bearing bank stamp/seal and signature of the bank manager for a period of three months with effect from the date of receipt of this letter for the preceding period of three months must be furnished immediately.

This must be continued to be submitted every three months without fail.

**AFFIDAVIT-**

Kindly ensure to comply with all the above stipulated and all other requisite Rules of Legal Education 2008 by way of compliance by way of duly notarized affidavit by attaching adequate documentation proof with the same with a period of 4 to 6 weeks for being eligible to be issued further Approval for further subsequent academic years.

After consideration, the Committee is of the view that as per Section 7 (1) (i) of the Advocates Act, 1961, Bilaspur Vishwavidyalaya, Chhattisgarh be granted recognition for the purpose of conferring the degree of law for imparting three year LL.B and five year integrated courses from the academic year 2012-13 subject to the conditions mentioned in the inspection report as stated hereunder: -

Further as per University's stand because of non recognition from the year 2012-2013, the colleges affiliated to it are facing problems in admitting students, and thus all colleges were got/should be affiliated to the University. Now, if affiliation is granted to each one of them for the year/s in question, they can apply to the Bar Council of India for approval of affiliation.

1. The University authorities should follow the Rule 16 of the Legal Education Rules-2008 and visit the law colleges under its jurisdiction within a month and inform the status of the law colleges to the Bar Council of India within the same period.
2. The University authorities should ensure the affiliated colleges whether they are following the norms of the Bar Council of India.

The University/College shall comply with the following Rule of the Bar Council of India (Clause (iii) and Explanation 2 of Schedule IV in Part IV of new rules of the Bar Council of India):-

*"Whenever approval of affiliation is granted to the Centres of Legal Education, it shall be necessary for the Centres of Legal Education to deposit Rupees Five Lakh in shape of guarantee to fulfill all the norms of the Bar Council of India. The same shall be liable to be*

After consideration, Committee is of the view that extension of temporary approval of affiliation be granted to D. P. Vipra Law College, Bilaspur for imparting three year LLB course with existing strength and further temporary approval of affiliation new five year BA.LLB course with two sections of 60 students in each section for a period of two years from 2012-13 to 2013-2014 subject to the following conditions.

1. The college should take admission for five year BA. LLB course only after receiving the extension of affiliation from the university for the academic year 2012-2013 because as per the statement of Principal, they had applied for the extension of affiliation to the university, without extension of affiliation the college should not admit any students in 5 years law course.






As authorized and deputed by the Bar Council of India, We inspected the D. P. Vipra Law College, Bilaspur on 16-06-2012. The above college is affiliated to Guru Ghasidas State University, Bilaspur, C. G. The above college is having temporary approval in respect of 3 years law course upto 2008-2009 and due to non-inspection Bar Council of India has granted approval upto 2011-12 because the college has deposited the inspection fees within time. The college has also applied for seeking fresh approval of affiliation for 5 years law course. They have deposited the requisite inspection fees. The instruction was in respect of the request for extension of approval of affiliation for the 3 years law course and fresh approval of affiliation for 5 years integrated B. A. LL.B. Course.

The previous inspection team of Bar Council of India has inspected and submitted the report and after that Legal Education Committee has granted the approval with the condition that the college has to appoint more teacher moreover the college has to purchase books worth Rs. 1,00,000/- within 6 months.

The above college is one of the oldest college of Bilaspur and it is run by a registered society named Sanatak Mahaviyalaya Shikshan Samiti, Bilaspur which is registered under the Societies Act. The population of Chhattisgarh State around 2083803 and population of Bilaspur City is around 6 lakhs. There are two Law College including this college. There is no 5 years law course college in the District and in the whole Bilaspur Division. In Bilaspur C. G. High Court is there and District Court, Consumer Court, Revenue Board, Labour Court, Revenue Court are there. Near about 3800 Advocates are practicing. There about 35 Colleges are there and near about 200 Higher Secondary School are there.

The Chhattisgarh Govt. has given N.O.C. for 5 years law course for 80 students vide letter No.366 dated 25.02.2006. Guru Ghasidas State University has given affiliation for 5 years law course vide letter No. 911 dated 5.4.2012.

### Building

The college is having its own building which is situated on the land which is around 1 lakh square feet, which is owned by the law college and at the time of inspection, the inspection team has given their documents at the principal who is present at the time of inspection with the University Members and they have also provided photo copy of the documents to the inspection team. Total build up area is around 20,000 square feet near about 70,000 square feet open. In the Ground Floor there are 6 class rooms and in First Floor there are 6 class rooms and size of each class room is about 22-30 feet. One Moot Court is available in Ground Floor in which around 300 students can be accommodated. 1 Library Hall is there in Ground Floor only. Principal's Office, Other office, Store Room, Girls Common Room, Boys Common Room, with separate Boys and Girls toilet. In Ground Floor only Computer Lab. is also situated there. In which around 10 computers can installed as per the Principal they have appointed 1 Computer Trainer who can Train the law students and they have also installed E. Library and in college premises there is wi fi zone. In college premises only at one corner girls' hostel and there also situated and the Matrons of the hostels is residing at the same premises. In the hostel students from remote area and from tribal area are residing.

Since the inspection of the above Centre of Legal Education could not be carried out due to unavoidable circumstances, After consideration, Council passed the following resolution in this regard :-

### RESOLUTION NO. 20/2011

" RESOLVED that existing Centres of Legal Education which have applied for extension of approval of Bar Council of India for/ upto the year 2011-2012 and have deposited the requisite inspection fee be granted approval of affiliation for a limited period of one year for academic year 2011-2012. In the meanwhile during the said period the Bar Council of India in the light of the provisions of the Advocate Act, 1961 contained section 7(i) read with Section 7 ( m) along with the rules namely, the Bar Council of India Rules, Part IV namely Rules 16,17 and 18 shall complete step ( 1) and step ( 2) process of inspection before further approval of recognition is granted to the Centres of Legal Education subject to them applying again for extension of approval of affiliation for the academic year 2012-2013.

Step 1 is that the Council must be satisfied that the university has a conscious and well informed enrolling body, has meticulously observed processes of affiliation and would take adequate regulatory control in relation to the said college of law/ centre of legal education . Step namely 2 the inspection of the college as well as its infrastructural facilities, faculty, fund, other facilities etc. It is reiterated that the primary responsibility shall be upon the University.

However the above resolution shall not apply to the following :-

1. The new centres of legal education which have applied for approval of affiliation or recognition of Bar Council of India.
2. Those centres of legal education which were inspected after 22<sup>nd</sup> August 2010 despite moratorium. List enclosed herewith as Annexure A.
3. The application for new courses or section by Centres of Legal Education. To clarify it is stated that if an existing centre of legal education applies for additional section or new course then no automatic approval is deemed to be granted based on the above resolution.
4. Those Centres of Legal Education which has been declined approval by Bar Council of India for the year 2010-2011 but has been given liberty to apply again.

It is further made clear that the extension of approval of affiliation now granted is coterminous with the affiliation granted by the University."

Since the aforesaid law college has paid the inspection fee, college authority are allowed to take admission during the academic year 2011-2012 for imparting 3 year course provided it has affiliation order for the academic year 2011-2012 of your university.
