Vipra Law College having its office Ashok Nagar Sarkanda, Bilaspur (CG) (herein after referred to as **"Internet Leased Line Consumer with 300 MBPS"** Through Dr. Annoo Bhai Soni its Principal to enter into and sign this Agreement for and on behalf of the Internet Leased Line Consumer, on the one Part, and

RELIANCE JIO INFOCOM LIMITED

Bilaspur (CG)

Hercin after referred to as **"Internet Leased Line Service Provider with 300 MBPS"** through Mr. Ankit Chouhan, as a Ter. Sales the Second Part.

NOW THIS AGREEMENT witnessed the following terms and conditions to be performed by both parties to the agreement.

Party 1st

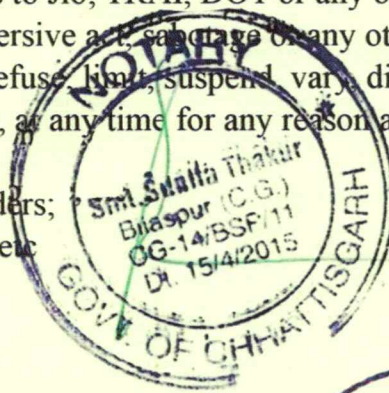
1. It is must to implement services within given duration.
2. Contract validity of minimum 1 year.
3. Institution has rights to discontinue the services after successful completion of agreement period.
4. Institution will pay the billed amount and other charges if and only if when the invoice generated.
5. If any problem persists for long time from the end of service provider (Party II) then institution can discontinue the connection/ services without any prior information.
6. All legal problems will be considered only in CG High Court, Bilaspur.

Party 2nd

1. All taxes will be charged extra at actual.
2. Contract Period of minimum 1 year.
3. Payment Mode: One Time Advance and Quarterly Advance of ARC (Along with the work order)
4. Validity of this offer is 30 days from the date of this proposal.
5. All commercials quoted in this proposal are exclusive of any in-country and withholding taxes. These will be applicable and payable by the customer.
6. Taxes extra at actuals
7. The contract will have a validity of a minimum one-year. In the event of cancellation of the order, customer will have to give Reliance Jio Infocom Limited a notice period of one quarter in advance and will have to pay for the reaming of the contract period.
8. Any Change in Tariffs/Regulation from Telecom Regulatory Authority of India (TRAI) would be applicable with immediate effect.

9. Jio Business Services shall not be responsible for any installation, commissioning or maintenance of any equipment or hardware unless supplied by Jio Business Services.
10. Force Majeure: If, at any time, during the continuance of the contract, the performance in whole or in any part by either party of obligation under the agreement is prevented or delayed by reasons of any war, hostile acts of the enemy, civil commotion, subrogate, fire, floods, earthquakes, explosions, epidemics, strikes and quarantine restrictions (herein after referred to as eventualities) neither party shall, by reason of such eventualities be entitled to terminate this contract agreement nor shall either party have any claim for damages against the other in respect of such non-performance or delay in performance. Performance of the contract agreement shall, however be resumed as soon as practicable after such eventuality has come to an end or ceased to exist.
11. Customer to be solely responsible for the content of the data and materials transmitted on network. No objectionable, obscene, unauthorized or any content or messages infringing IPRs and cyber laws, in any form or inconsistent with the laws, are carried in network.
12. Jio can change or amend the regulatory terms and conditions at any time as and when necessary to comply with any statutory, legal or regulatory requirements.
13. Customer to comply with all applicable laws and regulations including, the provisions of the Telegraph Act 1885, TRAI Act 1997, etc.
14. Jio to have the right to withdraw telecom services if such an action is necessary as per directive issued by the government body, regulatory authority or their authorized agencies.
15. Customer to provide necessary facilities to Jio, TRAI, DOT or any other Government Agencies to counteract espionage, subversive act, sabotage or any other unlawful activity.
16. Jio is entitled to, without any liability, refuse, limit, suspend, vary, disconnect and or interrupt the service, in whole or in part, at any time for any reason and/or due to various factors including but not limited to:
 - a. Government's rules, regulations, orders;
 - b. Combat potentiel fraude, Sabotage, etc






