Maternity Policy for D.P.V. Law College, Bilaspur, Chhattisgarh

D.P.V. Law College recognizes the importance of supporting faculty and staff members during maternity leave to ensure their well-being and promote work-life balance. This Maternity Policy outlines the college's commitment to providing comprehensive maternity benefits and support to eligible employees.

Faculty and Staff members of D.P.V. Law College are eligible for maternity benefits under this policy. Employees must have completed a minimum of one term of continuous service with the college to qualify for maternity leave.

Maternity Leave Entitlement

Female employees are entitled to a maternity leave of up to 26 weeks, including any prenatal leave and postnatal leave.

In case of complications arising during pregnancy or childbirth, additional leave may be granted as per the recommendation of a registered medical practitioner.

Prenatal Leave


Female employees may avail themselves of prenatal leave for a period of up to eight weeks before the expected date of delivery.

The duration of prenatal leave may be adjusted based on medical advice and the employee's individual circumstances.

Postnatal Leave

Female employees are entitled to postnatal leave for a period of up to 18 weeks following childbirth.

Employees may choose to commence postnatal leave immediately after childbirth or opt for a phased return to work, subject to approval by the college administration.

Maternity Benefits

During maternity leave, employees will continue to receive their regular salary and benefits in accordance with applicable laws and college policies.

Employees may also be eligible for additional maternity benefits as per government regulations and college policies.

Return to Work

At the conclusion of maternity leave, employees are entitled to return to their previous position with similar terms and conditions.

The college will make reasonable accommodations to facilitate the transition back to work, including flexible working arrangements and lactation support facilities.

Documentation and Notification

Employees must provide advance notice to the college administration of their intention to take maternity leave and submit relevant medical documentation as required.


Any changes to the duration or timing of maternity leave must be communicated to the college administration in a timely manner.

Eligibility for Freeship / Concession

1. In case of admission in the College taken either by the employees or their Son /Daughter /Dependents only University fees will be levied.
 2. In case of admission of the Son/ Daughter/ Dependents of such persons who fall under the criteria of below poverty line the 50% of the total fee levied by the college will be exempted subject to the submission of Relevant certificate.
 3. In the case of admission of Son/Daughter/Dependents of such person who died in Covid-19 epidemic 50% of the total fee by the college will be exempted on the submission of proper certificate. The Committee will take decision on the above matter under its discretion.
 4. The admitted students of the college who gets high marks or secures position in merit list will be exempted 50% of tuition fees.

Eligibility for Freeship / Concession

1. In case of admission in the College taken either by the employees or their Son /Daughter /Dependents only University fees will be levied.
2. In case of admission of the Son/ Daughter/ Dependents of such persons who fall under the criteria of below poverty line the 50% of the total fee levied by the college will be exempted subject to the submission of Relevant certificate.
3. In the case of admission of Son/Daughter/Dependents of such person who died in Covid-19 epidemic 50% of the total fee by the college will be exempted on the submission of proper certificate. The Committee will take decision on the above matter under its discretion.
4. The admitted students of the college who gets high marks or secures position in merit list will be exempted 50% of tuition fees.
5. The similar provision will be applicable for the students who participate in different State Level/National Level/ University Level/ Sports Competition and laureate medal /Prize.
