

### POLICY DOCUMENT OF RESTRICTED ENTRY OF AUTO MOBILES

At D.P. Vipra Law College, The aim of this policy is to mitigate environmental Pollution at regulating and restricting the entry of automobiles. This policy is to regulate and control the entry of the automobiles in the premises to ensure safety, security and efficient traffic management.

#### 1. Authorized Vehicles:

- Only registered vehicles with valid documents/ Number Plate are allowed on the premises.

#### 2. Entry Points :

- Access points for vehicles will be limited and security personnel will monitor entry and exit.
- Unauthorized vehicle access will be restricted.

#### 3. Parking Regulation:

- Vehicles must be parked only in designated areas.

#### 4. Visitor Parking:

- Visitors are required to register their vehicles at designated entry points.

#### 5. Enforcement:

- Security personnel will enforce the policy and conduct routine checks.


#### 6. Special Events:

- During special events, additional parking arrangements will be communicated, and temporary restrictions may be applied.

#### 7. Review and Amendments:
