





On August 21, 2018, Mr. T.R. Patel further explored the status of the ‘Right to Information as a fundamental right,’ elucidating its constitutional underpinnings and implications. The provisions of the Right to Information Act were meticulously dissected by Mr. Santosh Thakur from August 23 to 27, 2018, spanning six sessions aimed at providing participants with a comprehensive understanding of its legal intricacies. The session on August 28, 2018, led by Mr. Dharmendra Sharma, examined the ‘Impact of the Right to Information Act,’ delving into its tangible effects on governance, accountability, and citizen empowerment. Ku. Sushma Tiwari, on August 29, 2018, critically analyzed the ‘Criticism of Right to Information Act,’ fostering a nuanced discussion on its shortcomings and areas for improvement.

Addressing the practical challenges, Mr. T.R. Patel facilitated a session on ‘Issues and suggestions for effective implementation of Right to Information Act’ on August 30, 2018, offering insights into optimizing the Act’s efficacy. The course culminated with an evaluation on August 31, 2018, conducted by Mr. Santosh Thakur, assessing participants’ comprehension through a structured MCQ-based exam, consolidating their learning journey. Through this multifaceted approach, participants gained a comprehensive understanding of the Right to Information Act, equipped with both theoretical insights and practical strategies for effective implementation.

VALUE-ADDED PROGRAMME ON RIGHT TO EDUCATION

COURSE SUMMARY

Patel discussed provisions for free uniforms and books under the RTE Act on 28-09-2018 and concluded the course on 29-09-2018 by offering suggestions for enhancing the RTE Act's effectiveness.

In summary, the course imparted a holistic understanding of the legal framework surrounding education, encompassing both international perspectives and Indian legislative provisions. Moreover, it provided valuable insights into challenges faced and recommendations for improvements in education policy and implementation.
