## MOOT PROPOSITION

A girl named Simar aged 20 years, lived in a city in the Eastern province of the Republic of Hindia. She cleared High school with excellent grades. She was extrovert and used to raise her voice for all socio-economic issues.

Her family met a man named Lalit aged 23 years, who worked in the IT sector and belonged to a financially sound family in same community as Simar. Both the families mutually decided to get their children married.

After Marriage, Simar shifted to Vallahbad and started to reside with Lalit. After 2 years of the marriage, she conceived a child. She claimed that the intercourse between the couple that led to the pregnancy was against her consent and will. She was not physically as well as mentally prepared for the pregnancy and was not able to express her feelings with anyone. After initial weeks of pregnancy, she informed her parents about the whole incident. Her parents termed it as a marital obligation and suggested her to do whatever her husband wants. The thought of giving birth to a child caused her anxiety. She decided to abort her pregnancy. She visited a doctor for medical advice. Doctors refused to abort the child because she was 20 week, 6 days pregnant and this abortion is illegal as per Medical Termination of Pregnancy Act, 1971.

Being aggrieved by the medical advice, she contemplated the issue and finally decided to file a complaint in District Court of Vallahbad. Even after filing affidavit for expediate motion in the District Court, she was not able to get speedy relief.

The Courts in the Republic of Hindia are impartial and have always upheld the dignity of its citizen. From time to time, they have ruled judgement and laid down guidelines in the light of the welfare of it's citizens. The judiciary has always safeguarded the rights and interests of women, especially those involved in heinous offences.


Victim then decided to approach the Apex Court of Hindia under its original jurisdiction. The victim challenged the constitutional validity of Section 375 Exception II of Hindian Penal Code, 1860. The victim also claimed the right to abort her pregnancy of 22 weeks before the Hon'ble Apex Court.

The counsel for the petitioner, before the Apex Court of Hindia, contended that the pregnancy of a married woman due to forcible sex by her husband can be treated as rape under the Medical Termination of Pregnancy Act. The distressed situation of the Victim falls within the ambit of the act and the counsel seeks appropriate legal remedy for the Victim. During the proceeding, the counsel for the respondent stated that penal laws of the Republic of Hindia do not penalize sexual intercourse or sexual acts by a man with his own wife as rape further, it solely recognizes marital rape as an offence when the wife is below the age of 18 years.

The respondent counsel presented that the concept of marriage is sacred in nature under the personal laws and the object of the institution of marriage is for the procreation of children.

The issues raised before the Apex Court are as follows:

Issue 1- Whether the Petition filed by the petitioner is maintainable or not?
